

# SIDE EFFECTS OF mRNA VACCINES

5. There are 9 chemicals and Phenylethyleneglycol, a deep freezant in their vaccines like in their product for cancer therapy. This leads to damage to epitopes of the spike antigens. New viruses of different antigenicities are then created making no current mRNA vaccine or monoclonal antibodies effective. Because the mutants all have different antigens and not a shared common antigen, it is now impossible to make a new effective vaccine. It is a massive worldwide disaster.

# Finally! Medical Proof the Covid Jab is “Murder”

The journal Circulation is a well-respected publication. That's it. **That's the death bell for the covid-19 mRNA jabs.** The endothelium is a layer of cells lining blood vessels and lymphatic vessels. T cells are a type of white cell.

We always knew these jabs were experimental. My video in December 2020, just under a year ago, warned about these specific risks. I read out a list of possible adverse events published officially by the American Government. But now we have the proof of the link. The mRNA jab is, remember, known not to stop people catching covid. And it is known not to stop people spreading it. I don't believe anyone disputes these facts. And yet vast numbers of deaths and serious injuries have occurred among people who have been jabbed. Look at the item entitled [‘Updated: how many are the vaccines killing?’](#) on my websites.

Now we have the evidence to stop the jabbing programmes. In the study quoted in Circulation, a total of 566 patients aged 28 to 97 were tested. They were equally divided among men and women. ‘At the time of this report,’ says the author, ‘these changes persist for at least 2.5 months post second dose of vaccine.’ **At the very least, the use of these jabs must stop now. Immediately, until more long-term tests are done.** If there were any journalists left in the mainstream media, this news would be lead item on all TV and radio programmes and be on the front pages of all newspapers. I've said for a year that this jab was an experiment – certain to kill and injure.

We've always known that to experiment on people without their full consent and understanding – after disclosing all the risks and potential side effects – is a crime. # GRAPHENE HYDROXIDE

Dr. Andreas Noack is a chemist specializing in the production of activated carbon nanosheets and particles. He has a company located near Newcatle, England, which is the primary manufacturer of activated graphene material in Europe. His PhD research was about converting graphene oxide into graphene hydroxide. Graphene oxide molecule binds carbon with 2 oxygen atoms while graphene hydroxide binds the group OH (oxygen and hydrogen atom pair).

After reading the final version of the report of Prof. Pablo Campra, U. of Almeria, and inspecting the natural frequency of the graphene detected in the Pfizer solution he determined that it contains graphene hydroxide rather than graphene oxide. The graphene hydroxide is extremely strong, and durable.

It is NOT decomposable. It has the ability to release free protons that carry negative charges which help the graphene dissolve in liquid very well. Additionally, the negative charges induce acidity.

What is found in the vaccine are sheets of graphene hydroxide which are ONE ATOM thick (0.1 nm) but high and wide (50 nm and more) - in other words, they are EXTREMELY SHARP flat blades. Once they are injected into a patient's body they circulate in the bloodstream like razor blades and cut the epithelium with ease (epithelium is very smooth and thin).

Hence, we see many patients with massive "bleeding from the inside".

This is also why sportsmen drop dead at a higher rate than others because their blood circulates faster thus enabling intensified injury (cutting) of their epithelium.

## **DANGERS OF MASS INOCULATIONS AND REPEATED BOOSTING**

# UK GOVERNMENT ANNOUNCEMENT

0 to 4 years old 169,300

5 to 9 years old 180,600

10 to 14 years old 178,400

Estimated 10 to 11 years old =  $2/5$  of 178,400 = 71,360

Total children below 12 = 421,260 (169,300+180,600+71,360)

Source: Page 20 (Table 2)

Chance of kids <12 getting CV19 =  $15540/421260 = 0.037 = 3.7\%$  (I am only considering citizens. This percentage will be even lower if all residents <12 are included)

Thus chance of an infected child below 12 getting MIS-C is  $0.037 \times 64$  per 100K = 2.4 per 100K

Do note that the incidence rates for Anaphylaxis and Myocarditis are expressed as DOSES, meaning the incidence rate is actually higher PER PERSON. Let's say every person received 2 doses before getting the reactions. The numbers for Anaphylaxis = 0.8 per 100k and Myocarditis = 18.4 per 100K.

Therefore, there is a higher chance (3.8X - 7.6X) of getting Myocarditis (9.2 to 18.4 per 100K) from the injection compared to getting CV19 and then developing MIS-C (2.4 per 100K). Especially for males.

MOH doesn't even have the data of Anaphylaxis and Myocarditis for children below 12 to compare with. They have to use data from 12 to 19 yo. So how can they conclude that the injection is safe and effective???

“This is a bombshell,” said Children’s Health Defense (CHD) president and general counsel Mary Holland. “At least now we know why the FDA and Pfizer wanted to keep this data under wraps for 75 years.

These findings should put an immediate end to the Pfizer COVID vaccines.

The potential for serious harm is very clear, and those injured by the vaccines are prohibited from suing Pfizer for damages.”

## **Pfizer's Covid Vaccine Protection Against Omicron Fades Just Weeks After Second And Third Doses, Study Finds**

Immunity against the omicron coronavirus variant fades rapidly after a second and third dose of Pfizer and BioNTech's Covid-19 vaccine, according to peer reviewed research published in JAMA Network Open on Friday, a finding that could support rolling out additional booster shots to vulnerable people as the variant drives an uptick in new cases across the country.

### **KEY FACTS**

Levels of omicron-specific “neutralizing” antibodies—which can target the virus and stop it from replicating—decline rapidly after a second and third dose of Pfizer’s shot, according to the Danish study of 128 people who had received two or three doses.

Antibody levels, which are associated with protection against infection and disease, fell within weeks of getting the shots and were much lower than the level of antibodies specific to the original and delta coronavirus variants, the researchers said.

Compared to original and delta variants, the proportion of omicron-specific antibodies detected in participants’ blood dropped “rapidly” from 76% four weeks after the second shot to 53% at weeks eight to 10 and 19% at weeks 12 to 14, the researchers found.

Omicron-specific antibody levels increased after the third dose—nearly 21-fold at week three and nearly 8-fold at week four, compared to four weeks after the second dose—and the shot generated a detectable response in most people for at least eight weeks, the researchers said.

However, antibody levels started to drop as early as three weeks after the booster shot, falling 4.9-fold for the original variant, 5.6-fold for delta and 5.4-fold for omicron between weeks three and eight.

The “transient” antibody response after doses two and three mean additional booster shots might be needed to combat the variant, particularly among older people, the researchers said.

### **KEY BACKGROUND**

Experts and regulators broadly acknowledge the benefits of a third vaccine dose to top up flagging protection against serious illness and death. There is less consensus over whether additional shots are needed beyond that and questions over whether frequent boosting will be practical. Neutralizing antibodies have been the primary focus of studies evaluating vaccines—they are much easier to study—but they are not the only part of the immune system protecting humans against disease. Other parts of the immune system, such as T cells, might be less effective at preventing infection but they are more durable than antibodies and can reduce the chance of serious illness if infected. Many experts believe this latter property is the primary function of vaccination, not preventing infection, and data shows they offer much more durable protection, including against omicron.
